

"The **Atlanta-Carolinas HIDTA** (High Intensity Drug Trafficking Areas) will **launch a billboard** campaign for **fentanyl awareness** in the near future," according to **Katy Freund**, MPH Analyst for Overdose Response Strategy, Atlanta-Carolinas HIDTA.

The AZ HIDTA put together a toolkit in coordination with their state's Drug-Free Coalitions, which is free and available for anyone to use. The various media and presentations can be adapted for local campaign use.

Additionally, HIDTA proposes to host AZ HIDTA trainers to provide a fentanyl awareness workshop for those in prevention education to youth under 18.

### 17th Annual Drug and Alcohol Awareness Breakfast

# HARMONY GROVE BAPTIST BROTHERHOOD Flosts the 17TH ANNUAL DRUG & ALCOHOL AWARENESS Freakfast

On Saturday, January 21, several Forsyth County Drug Awareness Council members attended the 17th Annual Drug and Alcohol Awareness Breakfast held at Harmony Grove Baptist Brotherhood in Dawsonville. It was definitely worth getting up early on a cold Saturday morning to attend because the messages from the various speakers were so informative and inspiring.

The main speaker, Chuck Bragg, celebrates seven years of sobriety after 20 years of addiction. He recognizes that marijuana, other drugs, and addictions took away his childhood, dreams, and ambition. Even after the birth of his four children, he continued to use drugs and made excuses for using them. Chuck Bragg's sobriety began on the day he got out of jail, which happened to be his granddaughter's birthday. He finally admitted to himself just how much of his life and relationships he had lost due to his addiction to various drugs, and he recognized that he had let drugs rob him of his teens, 20s, and 30s. He knew sobriety would only be possible by bringing new people, places, and things into his life. Drug counselors often stress to "Change your playground and change your playmates" to escape addiction and succeed in leading a clean and sober life. From that turning point, Chuck dedicated his life to God and made the changes necessary to accomplish his new goals. He is presently an Associate Pastor at Chestatee Worship Center in Dawsonville, and he and his wife are leaders in the Celebrate Recovery program at Crossbridge Community Church in Dawsonville. Chuck Bragg wants his message to be a message of hope, and he gives credit to God and to all who have been a part of his recovery.

Throughout the morning, I heard powerful messages from the speaker and those in the audience who contributed ideas from their personal experiences related to drugs and addiction. I want to share some of these profound statements and facts. They are all worth repeating and worth remembering.



### Dana Bryan

Dana is a retired middle school teacher and member of FCDAC. Through her personal loss of her daughter to

drug experimentation, Dana devotes her time reaching out to youth through presentations about the real consequences and high risk of experimenting with addictive substances and how it affects them, their futures, and their families. She contributes her insights monthly to the *Strategizer*. Thanks, Dana!





- 1. We win or lose by the things that we choose.
- 2. Success is how high you bounce when you hit bottom.
- 3. Judge Deal states that the Celebrate Recovery program changed how he operated the Drug Court in Hall County.
- 4. It is important at all stages of life to choose our friends carefully.
- 5. We are only as good as the company we keep.
- 6. Show me who you are hanging out with, and I can tell you where you will be in a year.
- 7. Judge Bagley, Superior Court Judge in Forsyth County, has graduated 423 from the 2-year Drug Court Program. The goal is for every graduate to become a contributing member of society, and this is true for a remarkable percentage of graduates.
- 8. High schools are beginning to realize the value of drug counselors on staff.
- 9. The Forsyth County Drug Awareness Council is an umbrella to bring our community together to foster drug awareness and prevention.
- 10. FullCircle is a free program for ages 13-25 who are involved in destructive behavior. It is based on a 12-step program and includes participation from parents. We are fortunate to have a FullCircle program in Forsyth County under the leadership of Director Mike Cowan.
- 11. A Drug Summit will be held at FullCircle on February 8, 2023, at 4:30.
- 12. A person must want "better for themselves" for recovery to occur.
- 13. The source of drugs and alcohol for many youths is their household and parents.
- 14. Just because something is legal does not mean it is okay.
- 15. Commissioner Cindy Mills once met with a group of youths involved with drugs. Commissioner Mills asked if someone would share the one thing she wishes her parents had given her. You might think she would want a possession and possibly something expensive. The one thing she wished she had received from her parents was to "Give me boundaries." This is wise advice to all parents and profound that this young girl realized the importance of boundaries and the problems resulting in her own life from the lack of boundaries.

I hope that more and more adolescents, teens, and young adults will realize the serious dangers associated with the world of drugs and those who are a part of that world. If someone is struggling with addiction or with choices that can lead to addiction, please ask for help from one of the available resources or a trusted adult.

Senator Kay Kirkpatrick, M.D. Named Chair of the Senate Committee on Children and Families and Vice-chair of the Senate Committee on Health and Human Services

Update: This 3rd week of the session, Senator Kirkpatrick introduced Senate bill 22 relates to hemp products such as delta 8, which contain THC. It would require testing and labeling and prohibit the purchase or sale of ingestible hemp products by any individual under 18.

### New System to Track Non-fatal Opioid Overdoses Unveiled

On December 8, 2022, an NPR report by Brian Mann, the White House unveiled a new website\_that will track **non-fatal opioid overdoses**. Data collected by county-level EMS first responders in all 50 states and the District of Columbia will provide **updated reports on the website every two weeks**. Xylazine "Tranq" Overdose on the Rise

A Drug That Naloxone Can't Combat Last Updated: Friday January 27, 2023

**Xylazine** – often called "tranq" – is a drug adulterant that DEA has detected in a growing number of overdose deaths, despite the FDA authorizing it only for veterinary use.

Illicitly-used xylazine is most often reported in combinations with two or more substances present, such as fentanyl, cocaine, or heroin, and can increase the potential for these drugs to cause fatal overdoses. While scientists have not conducted much research on its effects, anecdotal reports suggest that users experience symptoms similar to those encountered via opioids, namely depression of the central

nervous system. More specifically, effects associated with xylazine use include dry mouth, drowsiness, hypertension, respiratory depression, and even coma. Users can develop a physical dependence to xylazine, reporting withdrawal symptoms more serious than from heroin or methadone, such as sharp chest pains and seizures.

Note: Since xylazine is not an opioid, naloxone does not reverse its effects.

Xylazine-positive overdose deaths have grown in all regions of the United States, according to the DEA. From 2020 to 2021, these deaths surged 103% in the Northeast, 516% in the Midwest, and 750% in the West, skyrocketing 1,127% in the South. But since xylazine is not currently included with the CDC's reporting of national statistics on fatal overdoses, it is very likely that the prevalence of the drug is widely underestimated.

The U.S. Controlled Substances Act does not currently list the non-opiate sedative, analgesic, and muscle relaxant as a controlled substance and a kilogram of the drug in powder form can be bought online from Chinese suppliers for \$6-20. Drug traffickers may increase their profits by using the adulterant, with the drug's psychoactive effects allowing the traffickers to reduce the amount of fentanyl or heroin used in a mixture.

## National Drug & Alcohol Facts Week® (NDAFW) March 20-26




National Drug and Alcohol Facts Week®, or NDAFW, is an annual, weeklong health observance that inspires dialogue about the science of drug use and addiction among youth. It provides an opportunity to bring together scientists, students, educators, healthcare providers, and community partners to help advance the science and address youth drug

and alcohol use in communities and nationwide. It was launched in 2010 by scientists at the National Institute on Drug Abuse (NIDA) to stimulate educational events in communities so teens can learn what science has taught us about drug use and addiction. The National Institute on Alcohol Abuse and Alcoholism partnered with NDAFW in 2016. Both NIDA and NIAAA are part of the National Institutes of Health and work with leading organizations, media outlets, and other Government agencies to spread the word about NDAFW.
